Introduction


- 2024 was a strong year with stable membership numbers and an increased participation rate.
- The Club is continuing to evolve to meet issues in the world around us, including the Cost of Living crisis.
- The MC continues to work to ensure the club is a "happy place", safe and friendly where everyone is treated with respect and dignity.

• Financial Overview

Despite increased costs, fee increases have been minimal.

- There has been a 16.5% increase in capitation fees payable to the Australian Bridge Federation (ABF) and calculated on the number of home club members.
- The masterpoint levy has increased by approximately 25%.
- By way of comparison, the UBC Home membership fee has increased by 14%.
 When you include table fees, say for someone who plays on average twice a week, the total fees paid to the club increase from \$580 to \$590 or 1.7%.
- With inflation running at 2.8% or 3.5% depending on what figures you look at, this is a great result, one which has come about due to responsible cost management.

The October Congress will be renamed to the St Ives Congress and there will also be sponsorship of a number of Saturday green point sessions.






